Bidahabanye n'intego yabyo yo gutanga serivisi zose z'ubuvuzi kandi bibikoranye urukundo bituma ubuzima bw'ababigana burushaho kumera neza, Ibitaro by'abana bya Deyitoni(Dayton) byiyemeje gutanga inkunga y'amafaranga kuri buri muntu wese ukeneye ubufasha bwihutirwa cyangwa ubundi buvuzi bwa ngombwa mu gihe uwo muntu yaba nta bwishingizi afite, cyangwa afite ubwishingizi kuri bimwe na bimwe, cyangwa atemerewe gufashwa n'izindi gahunda za leta, cyangwa mu gihe yaba adashoboye kwiyishyurira kubera ibihe by'ubukungu arimo.

Gahunda y'inkunga y'amafaranga itangwa n'Ibitaro by'abana bya Deyitoni(Dayton) ihabwa abarwayi badafite ubwishingizi n'abiyishyurira amafaranga arenga ku bwishingizi bwabo bujije ibisabwa mu rwego rw'imari hashingiwe ku itangwa n'isuzuma ry'amakuru n'ibyemezo bikwiye(Abarwayi bemerewe). Gahunda y'inkunga y'amafaranga(FAP) ni gahunda y'imfashanyo ishingiye ku mafaranga yinjizwa n'umuryango w'umurwayi. Abarwayi bafite imiryango yinjiza amafaranga angana cyangwa ari muni ya 400% y'Ibipimo by'ubukene byashyizweho na Leta zunze ubumwe za Amerika(FPG) nibo bemerewe inkunga y'amafaranga hashingiwe ku bipimo birutana mu buryo bikurikira:

Ingoboka ijyanye na COVID-19: Hatitawe ku makuru yatanze hejuru, mu gihe kibarwa guhera muri Mata 2020, Ibitaro by'abana bya Deyitoni(Dayton) bishobora kwemerera abarwayi igabanyirizwa rijyanye n'ingoboka y'amafaranga ya COVID 19 rya(30%) by'amafaranga umurwayi yari kwishyura. Kugira ngo umurwayi/umuryango wemererwe iri gabanyirizwa, bagomba kwandika basaba inkunga y'amafaranga mu buryo busanzwe bwo gusaba nk'uko bwagaragajwe muri aya mabwiriza. Muri icyo gihe, kuzuzwa neza ubu buryo bw'isaba bizatuma umurwayi/umuryango wemererwa igabanyirizwa ku mafaranga bari kwishyura. Iri gabanyirizwa rizajya ritangwa mu bubasha bw'Ibitaro by'Abana bya Deyitoni(Dayton Children's Hospital) mu bihe bifitanye isano n'ingaruka za COVID-19 zabaye mu gace k'abagize umuryango mugari wa Deyitoni(Dayton).

Abarwayi bafite imiryango yinjiza hejuru ya 400% y'Ibipimo by'ubukene byashyizweho na Leta zunze ubumwe za Amerika bashobora gukomeza kwemererwa inkunga y'amafaranga itangwa mu bihe by'amage hashingiwe ku muntu ubwe. Amafaranga umurwayi yakoresheje n'ayo agomba kwishyura nayo ashingirwaho mu isuzuma rigamije kwemeza niba yemerewe inkunga. Abarwayi bitezweho kugira uruhare mu kwishyura serivisi bahabwa hashingiwe k'uko umurwayi ubwe ahagaze mu bukungu; bityo, buri dosiye isuzumwa ukwayo. Inkunga y'amafaranga ntabwo ifatwa nk'ubundi buryo bwo kwishyura, kandi abarwayi bashobora gufashwa kubona ubundi buryo bwo kwishyura cyangwa indi nkunga y'amafaranga mbere yo kwemererwa muri Gahunda y'inkunga y'amafaranga itangwa n'Ibitaro by'abana bya Deyitoni(Dayton Children's Hospital).

Nta murwayi wemerewe inkunga uzishyuzwa andi mafaranga y'ubuvuzi bwihutirwa cyangwa ubundi buvuzi bwa ngombwa arenga ku mafaranga yishyuzwa muri rusange(AGB) ku barwayi bafite ubwishingizi bwishingira ubwo buvuzi.

3. Ishami rishinzwe ubufasha mu by'amafaranga rizasuzuma inyandiko y'isaba yujijwe hamwe n'ibindi byangombwa watanze kugira ngo ryemeze ibyerekeye ukwemererwa kwawe.
4. Tuzaguhamagara cyangwa tukwandikire nihagira andi makuru akenerwa kugira ngo wuzuze ibijyanye n'isaba

cyangwa igihe umwanzuro uzaba wafashwe. Twemerere iminsi 30 kugira ngo dusoze isuzuma.
